



III. OBJECTS OF THE TRUST



2. To establish institutions propagating ARTS & SCIENCE AND MANAGEMENT STUDIES.
3. To establish develop maintain and grant aid in cash or in kind to hospitals, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centers, and/or such other similar charitable institutions in India for the benefit and use of the general public.
4. To establish educational institutions offering diploma course providing employment opportunities such as DIPLOMA IN BUSINESS MANAGEMENT COURSE, MARINE DRIVING, NURSING AND NUTRITION COURSE, HOTEL MANAGEMENT COURSE.
5. To start, run establish PHARMACY COLLEGE AND TO ALIGN WITH PHARMACY council in this regard.
6. To establish, maintain, run, support or manage DENTAL COLLEGE.
7. To establish INDUSTRIAL TRAINING CENTER with all infrastructure facilities.

8. To establish, maintain, run and administer hospitals, nursing homes, medical relief centers, dispensaries and such other institution as may be found necessary and feasible to provide medical relief and treatment to the poor and needy public and to maintain ambulance for carrying on the primary purpose of the society viz.,

10. To co-operate, federate, align with International Philanthropically institution such as WORLD HEALTH ORGANISATIONS.
11. To make the people aware of ENVIRONMENTAL POLLUTION and the precautionary measures for control of the same.
12. To take steps as may be necessary to ameliorate the social, economic, civic conditions of the public at the large.
13. To establish, maintain, run or aid in establishing, maintaining, running and managing hostels, boarding homes, residential institutions for the benefit of the Students, trainees, apprentices, researchers or instructors without any profit motive.
14. To work for RURAL DEVELOPMENT.
15. To promote, organize, administer, establish, support maintain, grant and to receive from any persons, institutions or society or organizations whatsoever having similar objects of educational and or charitable purposes in India and to incur expenditure in condition therewith.

19. To make the people aware of T.B, diabetes and Cancer and Counseling treatment.

20. To organize annadhanam and develop feelings of amity amongst the general public, and to construct appropriate lecture/meeting halls, dining and rest halls for the purpose.

21. To celebrate birthdays of philosophers and learned men of wisdom who preserved/ preserve our ancient philosophy and classic education and thus represent the glory and heritage of our country.

22. To organize, conduct and hold classes. Lectures, meetings, seminars, workshops, training centers and other media or propagation for the promotion, instruction, diffusion and preservation of ancient literatures and knowledge in general and in ancient culture, values and to instill character and moral discipline through various means.

23. To establish, own or manage reading rooms, libraries, and hostels for rural people and training centers and run non-formal study centers in furtherance of above objectives.



28. To make pecuniary grants by way of prizes, stipends, allowances, subscriptions, fees or otherwise to/ and for the benefit of the students/ teachers of the institutions run by the Trust or other educational institutions having similar objects.
29. To print, publish, aid in buying, buy and distribute gratuitously or sell at concessional rates, such literatures, periodicals, journals, books, calendars, souvenirs, magnetic tapes, CD/DVD ROMs, MP3 or any type of taped music, in electronic media or otherwise and to maintain libraries in the above subjects, as may be thought subservient to the objects of the Trust.
30. To encourage new talents by awarding stipends, scholarships, travel grants, suitable financial aid for advanced training or otherwise and to facilitate pioneers by honoring them suitably and for payment of pension, annual grants, medical aid to deserving people and to render help to the deserving/ widows and families in their old ages or when incapacitated.
31. To grant donations, aid or any other kind of financial assistance to students, institutions, training centers, societies/ associations/ institutions founded for achieving social cause.
32. To accept contributions, in money or in kind, devises and bequeaths for all and any of the purposes aforesaid and manage the same.
33. To raise resources for augmenting income any of these purposes as may be permitted by law as the Board of Trustees deem fit and necessary.
34. To carry on the activity resulting in advancement of object of general public utility and which is not restricted to or for the benefit of any particular religious community or caste and which does not involve the carrying on of any activity for profit.

36. The Trust shall undertake any programme or conservation of natural resources or afforestation as approved by the prescribed authority which has been contemplated under section 35 CCB of the Income Tax Act 1961.

37. To provide legal aid and legal awareness to the weaker sections of the people.

38. To promote and carry on training programmes, short-term courses, conduct workshops, seminars and conferences for the youth in order to alleviate unemployment and underemployment to a large extent.

39. To support the Self Help Group and Young Entrepreneurs to succeed in their endeavors through training, providing finance help and to link them with banks

40. To promote and carry on value based education and to inculcate the human values in the minds of the younger generation.

41. To grant, pay or give scholarship, stipends, prizes rewards allowance or help in cash or kind to students with a view to help them in prosecuting their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching commercial and other arts including teaching of cultural arts music or other training research or educational works in India.



- b) To solicit, receive, hold and disburse funds to promote the objects stated above and to hold funds and investments in trust for the said objects.
- c) To appeal for and raise funds, subscriptions, donations and grants as the Trustees may think fit.
- d) To acquire any movable and immovable properties by purchases lease, hire, exchange or otherwise deal with and to pull down, erect, alter, and maintain buildings anywhere in India for the use of the Trust.
- e) To raise loans and / or advances or financial assistances from individuals, Trust, Associations, Society, Banks, other Financial Institutions & Government for the furtherance of the objects of the Trust.
- f) To draw, make, accept, discount, endorse, negotiate, sell, execute and issue bills of exchange, promissory notes, cheques, warrants, debentures and other negotiable or transferable instruments or securities.
- g) To subscribe, give donations financially or otherwise to any society / Trust which is having similar objects.
- h) To do all such acts, deed and things as or may be deemed necessary incidental or conducive to the attainment of all or any of the objects and purpose of the Trust.
- i) The Objects/activities of the Trust shall be carried out only in India.



- a. Mr. R.NARAYANAPRABHU shall be the Managing Trustee of the Trust and he has the full rights in operating the Bank account and he will be entitled to continue as such during his lifetime or until he resigns there from.
- b. The management and control of the affairs and funds of the trust shall be subject to the control and direction of the board of trustees.
- c. The Managing Trustee is empowered to co-opt Trustees for the trust and fix the terms of their appointment..
- d. The Trustees other than the Managing Trustee shall be liable to retire, as may be specified in the letter of invitation given to them.
- e. The number of Trustees shall not exceed 12 at any time.
- f. In the case of death, resignation etc., of the trustees the Managing Trustee has the power to appoint a person in his / her place as Trustee.
- g. The Board of Trustees will be change
- h. In the case of death, resignation etc., of the Managing Trustee, the other existing Trustees shall appoint a person in his/her place as Managing Trustee by a resolution supported by a simple majority of total number of trustees. In case the simple majority results in fraction it shall be rounded off to nearest higher number.
- i. The Managing Trustee has power to appoint at any time any other person as trustees by passing a resolution approved by a simple majority of persons attending the meeting where such appointment is discussed, subject to the ceiling.
- j. The Managing Trustee shall have power to appoint/remove committee members for all committees and sub-Committees of the Trust.
- k. The Trustees may reimburse themselves and pay and discharge out of the Trust Funds all expenses incurred by them in or about the execution of the Trust work/activities.

VI. Effect of appointment of new trustees

Upon every such appointment made in pursuance of the last foregoing clauses thereof, the newly appointed Trustees shall have powers and authorities of a Trustee under THESE PRESENTS.

VII. Powers to appoint committees

The Board of Trustees shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper, function under the authority and control of the Trustees for carrying out the objects of the Trust of these presents or the management thereof and invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the objects of the Trust.

VIII. Power to determine all questions of doubt or difficulty

It shall be lawful for the Board of Trustees to settle and determine all matters of interpretation of THESE PRESENTS as well as matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the trustees and powers of THESE PRESENTS and any such settlement or determination shall be valid, binding and conclusive and shall not be objected to or reopened upon any ground whatsoever.

IX. Power to Compromise

The Board of Trustees shall have the full power to settle compromise or compound, out of court, all suits, action and other proceedings and to settle all difference of demand and adjust the settlement of all accounts relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby.


X. Power to purchase, hire or take on lease

XI. Power to Borrow

XII. Investment of Trust Fund




XIII. In whose name money to be invested


XIV. Opening Bank Accounts



XV. Account and Audit

The Trustee shall maintain regular accounts of the trust funds and shall get the same duly audited by a firm of Chartered Accountants. The Accounts and Audit Report and report of Trust shall be made up at least once in a year covering the accounting period as may be determined by the Board of Trustees from time to time.



XVI. Present Immovable Property of the Trust

a) At present the Trust has no Immovable property.

b) In future, The Board of Trustees shall be entitled to purchase or hire or to take on lease an Immovable property or properties for the purpose of carrying out the objects of the Trust hereby created.

XVII. Receipts of the trustees

The receipts in writing by the Managing Trustee or any other person authorized by the Board of Trustees for any interest, dividend or income of the Trust Fund or for any deeds, papers, writing documents or other monies and effect payable to the Trustees shall be sufficient and effectual discharge for the same. The Board of Trustees by a resolution may also authorize any scheduled bank or other banks in India to collect any interest, dividend or income of the Trust Fund on the behalf.

XVIII. Power to amend the Rules

If in the opinion of the trustees, circumstance so require, the Trustees may unanimously make any amendment in the rules, they may consider necessary for the better management or administration of the Trust activities or for carrying out the objects of the Trust.

XIX. Power to make Rules and Regulations






XX. Power to Amalgamate other Trust or Vice Versa


XXI. Indemnity to the trustees etc
